2. Class Guidelines for the Fall Semester of 2021

- When you have been notified by the Korea Disease Control and Prevention Agency authorities of close contact with a COVID-19 confirmed person, and requested for testing, immediately notify the University by phone and do not come to campus (University Hotline: Weekdays 02-3277-2063, Holidays and Night-time 02-3277-5000).
- When you have suspicious symptoms, do not come to campus and immediately take a PCR test for COVID-19.
- If you have received a PCR test, please refrain from going outside and coming to the campus before you receive an official notice from the CDC that your test result is negative.
